

Estimated Bulgarian Adoption Costs

With all that is involved in an international adoption, the costs can add up quickly. Unfortunately, many of these costs are out of our control. Still, as a ministry, Lifeline is committed to keeping the costs as low as possible. Below is a current and comprehensive listing of all fees that will be included throughout your adoption process. Some of these expenses are estimates and may vary by state of residence, airfare changes, personal preferences, and special requests. When comparing Lifeline's fees to other agencies, please note that these fees include travel costs and document fees incurred by families during the completion of the adoption process, fees that are many times not included by other agencies as upfront fees. Please understand that the below fees are subject to change.

There is no additional fee if adopting more than one child as long as the children are located at the same orphanage. If they are not at the same orphanage then there would be an additional \in 2,000 fee for each child that is located at a different orphanage *(i.e. you could adopt multiple children for one fee if all at the same orphanage)*. Bulgaria fees are paid through Lifeline and not directly to Bulgaria.

The fee is paid in 4 installments as follows:

٠	€ 1000: due upon signing the contract with the Bulgarian agency	US \$1,323.59
•	€ 3000: due when deciding to travel for the first trip to meet the child and prior to the travel	US \$3,970.78
٠	€ 2000 for healthy child and € 1000 for special needs child: due upon final decision to proceed	
	with the adoption and paid upon the return back to the USA from the first trip	US \$2,647.19
•	€ 1000: due upon court order in Bulgaria granting the adoption.	US \$1,323.59

Fees are based on basic fees involved in adoption process. Fees may vary between \$24,000 - \$26,000 ** Not all adoptive couples will qualify for the adoption tax credit. Please consult your accountant or the IRS for a complete list of requirements. (Note that it is impossible to accurately predict expenses due to possible cost changes, etc.).

- ** Please note that the US \$ figures for the Bulgarian Adoption are based upon the exchange rate on 05/05/10 and will change depending on current exchange rate.
- ** The fees for Bulgaria should be calculated by EURO because the fee is in the EURO and the EURO amount is fixed and will not change although the \$US dollar figure will most likely change day to day!
- ** Please calculate the current exchange rate to determine what your US \$ Fee will be as this may change daily as the exchange rate fluctuates!
