Dear Mr Dohle,

I refer to your e-mail dated 23 January 2014 in which you make a request for access to documents.

I also refer to the holding reply of 13 February 2014 extending the time-limit to 10 March 2014, and to the response from Directorate General for Employment, Social Affairs and Inclusion (Ref. Ares(2014)591527 – 05/03/2014)

You wish to receive "all correspondence, notes (including emails/phone logs) related to contact between Lumos and EC officials related to the below issues:

- cooperation with Lumos to ensure sufficient funding in Bulgaria to implement the NAP.

- contacts with Lumos about the increase of EC funding allocated to deinstitutionalisation in Bulgaria, from 20 million to 40 million Euro.

- request of the European Commission to Lumos providing training to 50 desk officers from the European Commission in Brussels, who are responsible for billions of Euro of EC funds that can be used to reform health, education, and social services across EU member-States. Also, all documents related to training material, evaluation and followup.

- request of desk officers of the European Commission to Lumos to provide access to the Hungarian government on their planning for disability services.

Further to extensive research in Directorate General for Regional and Urban Policy of these documents until the date of your request, I regret to inform you that – similarly as it has been found in DG EMPL - no documents were found that would correspond to the description given in your application. In that respect, I would like to stress that Lumos, for many years, has undertaken its activities in Bulgaria with its own funds and has never applied or has been funded by the ERDF for activities in Bulgaria.
