Dear Mr Veith,

On 29 May this year, we commemorated the fact that it was ten years ago when the Hague Convention of 29 May 1993 on Protection of Children and Co-operation in Respect of Intercountry Adoption was first signed at the Peace Palace at The Hague, following its unanimous approval by 66 States.

Following the most recent ratification by India, the Convention now has 53 Contracting States, both countries of origin of children and receiving States, in approximately equal numbers. There is no question that the Convention has already contributed to establishing sound intercountry adoption practices worldwide.

The role of Central Authorities – your role – is critical to the operation of the Convention. The importance of this role cannot be overstated: it is no easy matter to discharge the many duties which the Convention imposes upon the Central Authorities, including the task of maintaining fruitful co-operation with counterparts all over the world. Within the limits of its resources, the Permanent Bureau does what it can to assist Central Authorities, and will continue to do so, in close co-operation with other institutions such as the UN Committee on the Rights of the Child and UNICEF, and non-governmental organisations such as the International Social Service International Resource Center for the Protection of Children in Adoption.
